License/Permit Type	To-Go/Parking Lot Pickup	Off-Site Delivery to Consumers
Brewer's License (BW) Formerly Brewer's Permit (B) and Manufacturer's License (BA)	Allowed (If eligible under 62.122)	Not allowed
Distiller's and Rectifier's Permit (D)	Allowed	Not allowed
Winery Permit (G)	Allowed	Allowed by direct shipping through the holder of Carrier's Permit (C), or delivery in vehicles owned or leased by the permit holder (or their agent). All packages must be properly labeled (see Alcoholic Beverage Code Section 16.09(b)).
License/Permit Type	To-Go/Parking Lot Pickup	Off-Site Delivery to Consumers
Wine and Beer Retailer's Permit (BG)	Allowed	Allowed through Local Cartage Permit or CD Permit (not allowed if also a Brewpub)
Wine and Beer Retailer's Off-Premise Permit (BQ)	Allowed	Allowed through CD Permit
Beer Retailer's Off Premise License (BF)	Allowed	Allowed through CD Permit
Package Store Permit (P)	Allowed	Allowed. Can also deliver through CD permittee.
Wine Only Package Store Permit (Q)	Allowed	Allowed. Can also deliver through CD permittee.
BrewPub License (BP)	Allowed in accordance with the additional retail-tier permit the business holds	Allowed if also hold an MB with an FB or BE License. NOT allowed if the BP holds a BG Permit at the location.
Consumer Delivery Permit (CD)	Not applicable	Allowed
