THE TABC STRONGLY FEELS THAT TRAINED SELLERS, SERVERS, AND MANAGERS ARE BETTER ABLE TO IDENTIFY AND PREVENT SALES OF ALCOHOLIC BEVERAGES TO MINORS, INTOXICATED PERSONS, NON-MEMBERS OF A PRIVATE CLUB, AFTER HOURS, AND MANY MORE. - (II) Possession of distilled spirits without local distributor stamps on the container in violation of §28.15 or §32.20
- (III) Retail cash/credit laws violation of cash or credit laws by retail licensee or permittee in violation of §§61.73, 102.31 or 102.32.
- (IV) Selling alcoholic beverage to a minor in violation of [Chapter 106],Alcohol Beverage Code and is subject to criminal penalties.
- (V) Selling an alcoholic beverage with criminal negligence to an intoxicated person is a violation of Section 101.63 of the Alcoholic Beverage Code.
- (VI) Violation of city codes (relating to health, safety and welfare).

THE TEXAS ALCOHOLIC BEVERAGE CODE IS COMPRISED OF STATUTES CREATED OR AMENDED BY THE TEXAS STATE LEGISLATURE THEREFORE, THE COURTS HOLD BAR AND NIGHTCLUB OWNERS TO A HIGH LEGAL DUTY OF CARE (OBLIGATION) TO DO EVERYTHING REASONABLY POSSIBLE TO PROTECT THEIR PATRONS FROM FORESEEABLE HARM.
